Please initial **each** of the terms below. Sign the agreement and return to the office of FGBI as soon as possible. Quantities may be limited. Book rentals are on "First paid, first served basis."

INITIAL

1. \_\_\_\_\_ I hereby commit to rent the textbooks as shown on the receipt. I have paid the nonrefundable rental fee, and understand that there is no refund.
2. \_\_\_\_\_ I acknowledge that the books, whether new or used, are in good condition. (Inspection will be done at the time of delivery.)
3. \_\_\_\_\_ I acknowledge the non-return replacement cost and replacement fee will be 200% of the rental fee. (For example: if you rent a book for \$10.00 and do not return it, the cost of purchasing the book will be \$20.00.) I authorize FGBI to add this amount to my school bill.
4. \_\_\_\_\_ I will return the book to the Bookstore no later than the rental return due date.
5. \_\_\_\_\_ I acknowledge that this book rental agreement terminates immediately upon my withdrawal or dismissal from FGBI.
6. \_\_\_\_\_ I will return the book in good salable condition as determined by the Bookstore. All CD's and other component parts included with this book, must be present and in salable condition as determined by FGBI upon return. Highlighting and writing in the book is not acceptable.
7. \_\_\_\_\_ I am responsible for risk of loss from any cause, including theft, lost item(s), or return in unsalable condition, such as damage caused by liquids (rain, snow, coffee, juice, etc.), fire (scorched), chemical spills, tooth marks (rodents, pets, etc.), missing component parts, and spine damage. Removal or destruction of UPC code identifier renders a book unsalable.
8. \_\_\_\_\_ If the Non-Return fees are not paid within 30 days of the due date, I acknowledge and agree to pay a \$20.00 late fee.
9. \_\_\_\_\_ I acknowledge that each book has a UPC code identity.
10. \_\_\_\_\_ Books are not issued until rental fees are paid. (First paid, First served basis) No books are held in reserve for unpaid agreements.
11. \_\_\_\_\_ I agree to pay a 10% cancellation fee for any part of this order that is cancelled.
